### 2012 Grants

This year was the foundation's 10<sup>th</sup> anniversary as an education grantmaker. We continued to meet the increased needs of our nonprofit partners during the economic recovery, providing stepped up financial and technical support for local educational nonprofits.

For the first time, the foundation offered two rounds of fundraising challenge grants, in response to our nonprofit partners' description of their common need to a) meaningfully re-engage lapsed donors, and b), reach out to new stakeholders and individuals in the community in a new and different way.

In addition, we increased our work with nonprofit partners who collaborate through the Education by Nature projects. We seed funded these projects in Los Angeles, Silicon Valley, and Hawaii, and promoted collaboration and this collaborative model nationally. We funded the redesign of the software platform used in these collaboratives, and will provide at no cost to prospective partners across the country a 2.0 version that provides improved usability and new features based on the "wish lists" of the nonprofits advancing this work. We undertook intense "shared marketing" projects, including creation of two video documentaries, two websites, social media, and two national conferences featuring sessions, exhibits and special events that disseminated promising practices achieving impact by generating collaborative and strategic partnerships and community engagement in public school education.
